Lupo lives in a track house, owns a big shiny car, has two small boys and a dog, and his wife, Mary, is active in the local chapter of the Movement to Preserve the Status of Women.

Judge Putman and
Picture opens with the police, Lupo and the Mission County
Court barging into a little adult film arcade on an amuse-
ment pier, sandwiched between the merry-go-round and the
fun house. The raiding party flushes the customers out
of the booths, corrals them in a corner and holds a night
session of court right there on the premises to determine
whether there is probable cause to issue a warrant to
seize any "obscene matter." Putman enters a booth, looks
at a porno short entitled "The Salesman," comes out and
finds probable cause. Police then proceed to rip the booths
apart, seize everything in sight and arrest Lee St. John,
the gay co-proprietor. St. John's partner, Opal Frost,
escapes arrest by posing as a customer.

Next morning, a giant black tattooed heroin dealer named
Ray Charles Jackson is about to rape St. John inside the
Mission County Jail when deputy sheriffs appear to take
them and two dozen other prisoners to court. All prisoners
wear coveralls and tennis shoes, are hooked to a ~~heavy~~ chain,
and transported in a long bus with barred windows.
